



On Sunday, April 30, 2017, at 0232 hours, I was dispatched to 7087 Miller Lane in Butler Township, Montgomery County, Ohio, on a traffic complaint. According to the dispatch, a caller advised that they had struck a shopping cart in the road at this location.

On arrival, I saw two Walmart shopping carts. One of the carts was still in the roadway in the center left turn only lane, and the other was on its side off the right side of the road by the mailboxes for 7125 and 7087 Miller Lane.

The mailbox for 7125 Miller Lane was on the ground with its locking door off its hinges. There also was several pieces of mail on the ground by the mailbox. The mailbox post for 7087 Miller Lane was knocked completely down, and the box was still attached to the post. It appeared the Walmart shopping cart had struck box mailboxes during the crash. There was no evidence that a motor vehicle hit the mailboxes. I moved the other shopping cart out of the roadway.

I contacted the caller, Jennifer L. Kiser, by phone. Kiser did not want to file a report since they were not going to file an insurance claim. I explained that I would have to do a report anyway, since other property than her vehicle was damaged from the incident. Kiser cooperated and explained what had happened.

Kiser said her husband, Brandon L. Kiser, was driving, and she was sitting in the front passenger seat of their grey 2005 Chevrolet Trailblazer, bearing Ohio registration HAY 6526. Kiser said they were southbound on Miller Lane, and they struck a shopping cart in the roadway. Kiser said they continued on home, and they were unaware the shopping cart had hit the two mailboxes Kiser said it was raining heavily when they struck the cart, and they did not see it until they were right on it.

I advised Kiser I would be completing a report and requested permission to photograph their vehicle. Kiser gave permission and said that it would be at 3170 Autumnridge Court in Butler Township. I advised Kiser that I would not be issuing a citation, since the cart was in the roadway, and there was no evidence at the scene to indicate that a motor vehicle hit the mailboxes. Brandon was found to have a valid Ohio driver's license.

I contacted the desk clerks at both motels and provided them with the report number for the crash report. At about 0500 hours, I went to 3170 Autumnridge Court and photographed Kiser's vehicle. The vehicle had damage to the right front bumper area. It also had striated and crosshatched markings on the bumper, which were consistent with hitting a shopping cart.

At this time, it was unknown how the shopping carts ended up in the roadway, as there are no known witnesses to the incident.

There was nothing further to report at this time.
