

NARRATIVE

On May 9, 2017, at approximately 0215 hours, the owner of Unit 2 heard a "loud bang" outside his hotel room, and when he looked outside, he noticed a dark vehicle traveling south, away from his legally parked truck, which was facing north at the time of the impact.

The suspect was last seen fleeing the scene in an unknown direction on Miller Lane. When damage was discovered on the driver side front door of Unit 2, he asked the hotel manager to contact our agency for a report. I noticed a few pieces of red plastic from Unit 1's taillight cover on the pavement next to the driver side of Unit 2 indicating Unit 1 back into Unit 2 before leaving the property (See OH-2 narrative for more details.)



On May 9, 2017, at approximately 0305 hours, Officer Harlow and I responded to the Days Inn Motel, which is located at 7470 Miller Lane, Dayton, Ohio 45414 for a hit and run crash involving a parked vehicle.

The victim, Jason Richison, stated he was in his room when he heard the loud bang, and when he looked outside, he saw a dark colored, mid size vehicle driving away in a hurry. Jason went over to his 1998 Ford F150 parked about 30 feet away from his room, noticed fresh damage to the lower portion of the driver side door and rocker panel. Jason said he then went to the front desk clerk to have her call the police.

Officer Harlow spoke with the front desk clerk and also left her with a statement form to complete. I did not speak with this witness at this time.

On May 11, 2017 at 0300 hours, I stopped by the Day's Inn hotel, located at 7470 Miller Lane, to follow up with the witness, Francheska Goodson, who was the front desk clerk for the Day's Inn at the time of this crash.

Francheska advised she heard yelling just outside the front lobby doors around 0230 hours. Francheska advised the yelling was coming from a white female and black male in their twenties. These subjects then walked away heading north out of her sight. When Francheska stepped outside, she heard what sounded like two car doors slamming, which was followed by a loud crashing sound. Francheska believed the noise she heard was the impact between the suspect vehicle and victim's parked Ford F-150.

Francheska did not see the car back into the truck, but she did see them driving away from the area where this truck was parked. Francheska noticed the female was driving, and she left the lot at a high rate of speed. The suspect vehicle was followed by a blue Ford Mustang, which she believed was the pizza delivery driver from Cousin Vinny's.

Francheska described the female as being around 5'05" tall with a slender body and shoulder length hair that was dyed multiple colors such as green, blonde, and pink.

I am attempting to obtain video from the Day's Inn surveillance system to assist with this investigation. No pictures were taken of Unit two or the scene on the night of the crash. The plastic taillight pieces were small and did not have any markings on them indicating the make of vehicle therefore, they were not collected as evidence.
