





Unit 2 told me she was driving northbound on Aullwood Road. Unit 1 was driving southbound toward her. Unit 2 told me that she pulled over as far as possible, but since both vehicles were large trucks, they struck driver's side mirrors. Unit 2 described Unit 1 as "flying" according to her written statement. The driver of Unit 1 exited his car, picked up his mirror, and left.

The driver was an older white male who retrieved his mirror and left. Unit 2 asked Unit 1 if he was going to wait for the police, but he said no and left. She described him as 50 to 60 years old with grey or blonde hair and around 250 pounds. She did not get his license plate number.

I saw that her truck had a broken driver's side mirror. The mirror was broken but in one piece. The shell of the mirror had folded and only received a black plastic mark. There was no evidence of paint transfer. After I used my department issued digital camera to photograph the damage, I obtained a written statement from Unit 2 detailing the events of this crash.

I responded to the area of the crash and examined the roadway. I noted the roadway was divided by a double yellow center line with 2 fog lines on each side of the roadway. I did not see any debris in the roadway. The asphalt roadway appeared intact, and there were no anomalies to note. The direction of the sun was from the west to the east and did not create any obstructive properties as I drove the roadway. Shrubbery from the park was heavy on both sides of the roadway but again created no obstruction.

Based on the fact this was 2 vehicles striking mirrors, and one left the scene, the only investigation was the statement of the unit who called this in. Due to the lack of investigative leads, I request this case be suspended until such leads are available.
