



On Tuesday, June 6, 2017, at 1419 hours, I was dispatched to the intersection of Frederick Pike and US 40 (West National Road) in Butler Township, Montgomery County, Ohio, for a property damage hit/skip crash.

Upon my arrival at 1426 hours, I made contact with Cynthia D. Smith, who I identified via her Ohio Driver License, who was driving a blue 2011 Ford Escape, bearing Ohio registration FEA8069, and who gave me her report. Smith stated that she was driving northbound on Frederick Pike, and when at West National Road, she had stopped for a red traffic signal. Smith continued that she was struck by a blue small sports utility vehicle, which fled after striking her by heading westbound on National Road.

Smith could not give any make, model, but she stated that the driver was a white male. Smith also stated that she saw something fall from the other vehicle as it turned onto westbound West National Road. I observed a rub on the left rear corner of Smith's vehicle. I took four digital photographs of Smith's vehicle, and I obtained her written statement and her insurance information.

Also on scene was George C. Thomas, who I identified via his Ohio Driver License, and who gave me his report. Thomas reported that he was traveling northbound on Frederick Pike when he passed a newer model blue Ford Escape on Frederick Pike north of Meeker Road. Thomas continued that the newer Escape accelerated, passed him, and then cut in front of him striking an older model blue Ford Escape, which was stopped in traffic at West National Road. Thomas continued that the newer Escape then fled westbound on West National Road. Thomas did not get the other vehicle's registration. I obtained his written statement.

I went to the grassy area on the southwest corner of the intersection where unit #1 had traversed as it fled and located a right hand side view mirror. I retrieved it as evidence.

Later in the afternoon, I was contacted by the Englewood Police Officer Blankenship, who stated that he had responded to a disorderly at 1107 Sunset Drive in Englewood, where a white female was arguing with a white male regarding a crash. The Ohio registration of a blue Ford Escape on scene was EUA8761. He stated that the female identified the driver of the vehicle as Justin Miller.

I drove to 1107 Sunset Drive and located a blue Ford Escape bearing Ohio registration EAU8761. I examined the vehicle and observed that it had sustained damage to its right front corner consistent with the crash I was investigating. I took five digital photographs of the vehicle. The right hand side view mirror was missing from the newer Escape. The mirror I recovered at the crash scene was a perfect match for the missing mirror.

A woman exited the home and stated that the Escape belonged to her mother, Carmen E. Dooley, and the woman stated that Dooley was a passenger in the vehicle, when the crash occurred on Frederick Pike at National Road. The woman stated that she was Dooley's daughter. She also stated that Justin Miller, her daughter's ex-boyfriend, was the driver of the vehicle. She stated that Miller lived at 605 Wolfe Avenue in Englewood. I left my business card and requested that Dooley see me at her earliest convenience.

On Wednesday, June 7, 2017, Dooley met me at the Butler Township Police Department and provided her written and verbal statement. Dooley stated that she wanted to go to the Monnin Fruit Farm on Frederick Pike. She continued that Miller asked to drive and she, believing that he had a license, consented. Dooley continued that after making her purchases at the fruit farm, they were en route back home going northbound on Frederick Pike when they were passed by another vehicle.

Dooley stated that Miller became enraged and started chasing the other vehicle and ultimately passed it as they neared West National Road. Dooley stated that Miller cut in front of the other vehicle, but he could not stop before colliding with an older blue Escape, which was stopped in traffic at

National. Dooley stated that after the collision, Miller turned left and proceeded westbound on West National Road. I searched for Miller and located him in the LEADS database, where I learned that his Ohio Driver License was suspended. Miller provided me with her insurance information. I completed an exchange of information form and mailed it to both Smith and Dooley.

I prepared traffic citation 42622 citing Miller with assured clear distance ahead, driving while under suspension, and failing to stop after an accident on a public road or highway in violation of 4511.21(A), 4510.11, and 4549.02 of the Ohio Revised Code.
