



Upon arrival, I met with unit 2 in the lot. I saw his vehicle was parked in a stall on the southern line of stalls, closest to the building. I saw his front right headlight and bumper area had sustained damage.

He told me that he arrived at the store, and he parked in the lot and walked into the Liquor and Wine Warehouse. While in the store, an unidentified person said that a car had been struck in the lot. He walked outside and saw the driver of a white Hogan Truck and Leasing box truck leaving the lot. He discovered the truck had struck his vehicle and called police. The driver had failed to stop and provide any information after the crash.

While he waited on me, he learned from another unknown person that a female was driving the truck, and there was a child, unknown age, in the passenger seat of the truck. All other witnesses were gone, but he learned the liquor store had surveillance video that captured the crash. Officer Maples arrived on scene and photographed the car, while I looked at the video.

I could see a white box truck with Hogan Truck leasing on the side as it pulled into frame from the east to the west. The driver made a turn to the north just west of unit 2. As the driver proceeded, the back right tires of unit 1 drove into the front right of unit 2 knocking unit 2 backwards slightly. Unit 1 stopped and backed up in order not to run completely over unit 2. Unit 1 corrected the path and continued driving back toward the west out of the lot, and it then proceeded eastbound on York Commons Bl. I could not clearly see any numbers or the license plate on the video, and the manager will burn me a copy later this week.

On Monday, June 12, 2017, at approximately 1340 hours, I called the Hogan Truck Rental and Leasing company and spoke with Aaron Focht. He responded to the store to look at video. I learned that their company had several rental agencies in the region, and it would be difficult to find the right truck without the numbers from the side of the truck.

Mr. Focht looked at the video, and he believed the truck was a 2015 Freightliner M-2, which they have several. He said he would check around and try to find one with damage, but at this point, it was almost impossible to track without the numbers. He also told me the insurance was held by the individuals who rent the truck. I provided him with a card with the report number, and he said he would call if he got a lead on by whom the truck may have been rented.
