



On Thursday, June 29, 2017, at 1636 hours, Officer T. Maples and I were dispatched to 7610 Roselake Drive in Butler Township, Montgomery County, Ohio, for a property damage crash.

Upon our arrival at 1640 hours, I observed a white Chevrolet pick up truck bearing Ohio registration PBS4194 and a gold Ford Taurus station wagon bearing Ohio registration HAH4311. The truck was parked in front of 7610 Roselake Drive and the station wagon was stopped in the middle of the road just south of the truck. I identified the driver of the truck as Terry L. Bennett via his Ohio Driver License and the driver of the station wagon as Zachary T. Finnegan via his Ohio Driver License.

I also observed a Chevrolet Trailblazer parked north of both vehicles. I identified the driver of that vehicle, Kathleen E. Davis via her Ohio Driver License, and learned that he had observed the crash. I obtained Davis' verbal and written statement. Davis stated that she had been behind the Ford on Little York Road traveling westbound on Little York Road and had observed the vehicle drifting into the on-coming lane on multiple occasions. Davis then observed the Ford turn southbound onto Roselake Drive where she observed the Ford cross into the on-coming lane and strike the Chevrolet, which had stopped at 7610 Roselake Drive.

I returned to Bennett and obtained his verbal and written statement. Bennett stated that he observed the Ford cross into his lane of traffic and he came to a stop in front of 7610 Roselake Drive. Bennett observed the Ford strike the truck he was driving with both left front tires meeting each other.

I went to Finnegan and received his verbal and written statement. Finnegan stated that he was distracted by his cellular telephone and recognized that he had swerved into the on-coming traffic on multiple occasions. Finnegan continued that the phone fell off the stand he had it on and when he reached to retrieve it he swerved and struck the truck. I observed that Finnegan had glassy eyes and asked if he had been drinking. Finnegan admitted to drinking earlier in the day. I administered the horizontal gaze nystagmus test to Finnegan as witnessed by Maples, but did not observe any clues.

I completed an exchange of information and gave each party their copy. I took several digital photographs of the crash scene. Finnegan requested that I call Busy Bee at his request, which I did. Bennett, was was driving a truck belonging to his employer, Mats Equipment Company called his own tow service. Both tow services arrived and towed both vehicles away.

I issued citation 42624 to Finnegan for failure to control in violation of 4511.202 of the Ohio Revised Code. I also cited Finnegan for an expired registration as I had learned that his registration had expired on earlier in the month. Finnegan's grandmother had arrived on scene and I released Finnegan to her and they departed.
