



On Sunday, July 23, 2017, at 0032 hours, I was dispatched to the Butler Township Police Department located at 3510 Sudachi Drive in Butler Township, Montgomery County, Ohio, for a property damage hit and skip crash that occurred near 6851 Miller Lane in Butler Township, Montgomery County Ohio on Sunday, July 23, 2017, at 0006 hours.

Upon my arrival at 0046 hours, I made contact with the complaints, Joseph P. Matthews and Forrest W. Parrott who I also identified via their Ohio Driver Licenses, who gave me their reports. Matthews is the owner of a silver 2004 Chevrolet Malibu bearing Ohio registration HDR6528. Matthews and Parrott were driving southbound on Miller Lane when they were struck from behind by a dark colored four door sedan. Both stated that after the impact, the sedan went around their vehicle to the right, and fled the scene. Matthews and Parrott gave chase and obtained the registration of the vehicle that struck them. The registration on that vehicle was Ohio registration DNZ6419. Both stated that the vehicle ran red stop signals before they lost the vehicle as it turned onto southbound Interstate 75. I took five digital photographs of Matthews' Malibu and received their written statements.

I contacted Englewood dispatch and requested that an Union Police Officer respond to 118 South Old Mill Road apartment 507 in Union to make contact with Nancy C. Trisdale, the registered owner of the vehicle bearing Ohio registration DNZ6419. Later a Union Police Officer called and stated that he had made contact with Trisdale who stated that her grandson, Zachary P. Williams, should be driving the car, but he was not currently at home.

On Thursday, July 27, 2017, at 1928 hours, I went to 118 South Old Mill Road apartment 507 in Union, Ohio to contact with Trisdale and Williams. I located a black 2007 Ford 500 bearing Ohio registration DNZ6419. The Ford's hood and fenders were a primer color and appeared to have been recently replaced as they did not have any apparent damage related to the crash. I took three digital photographs of the Ford. Prior to knocking at the door, I activated a digital voice recorder. I knocked at the door to the apartment and Trisdale answered. I recognized Trisdale from the LEADS database photograph from running Ohio registration DNZ6419. I asked for and received permission to enter the apartment where I asked to speak with Williams. Trisdale retreated to a bedroom, knocked, and informed Williams that he had a visitor. Williams entered the living room where I identified him via his Ohio Driver License. I asked Williams to tell me about the crash on Miller Lane and he admitted to being involved in a small fender-bender. I asked why he fled the scene and he stated that he was nervous. I asked how the accident occurred and he replied that he looked down to adjust the radio and looked up upon impact. I obtained Williams' insurance information and issued him citation 42958 assured clear distance ahead in violation of 4511.21(A) of the Ohio Revised Code. I advised the defendant of his court date of Thursday, August 3, 2017, at 0830 hours, I further advised Williams that if he did not show up for court, he could face additional criminal penalties.

On Monday, July 31, 2017, Sergeant T. Stanley reviewed my crash report. Stanley counseled me regarding the elements of stopping after accident on public roads or highways in violation of 4549.02 of the Ohio Revised Code. Stanley pointed out Williams lack of making any attempt to report the crash as well as the apparent recent repairs on the Ford to disguise any involvement in a crash. Stanley also pointed out that absent my identifying and visiting Williams, Matthews would have bore the cost of the accident himself. I decided to issue an additional citation to Williams for violating stopping after accident on public roads or highways in violation of 4549.02 of the Ohio Revised Code. I drafted citation 42963 for service upon Williams.
