



On Sunday, July 23, 2017, at 1524 hours, I was dispatched to the Walmart located at 3465 York Commons Boulevard in Butler Township, Montgomery County, Ohio, for a private property hit and skip.

Upon my arrival at 1529 hours, I made contact with Martin D. Kilberg, the registered owner of a red Ford F-150 series pick up truck bearing Ohio registration GTQ3005 who was parked in the sixth parking space on on the southern half of row 8. I received Kilberg's report. Kilberg stated that he parked his truck in the parking spot at approximately 1452 hours. He entered Walmart, completed his shopping, and returned to the truck at approximately 1515 hours, where he noticed damage to the left side of his truck. I took three digital photographs of the vehicle. I observed faint white paint transfer were another vehicle rubbed against his. I did not observe any dents, just the paint transfer. There was a white Dodge parked next to Kilberg's vehicle, but it did not have any damage or paint rubs on it. Kilberg stated that the Dodge pulled into the parking spot after he had noticed the damage.

I gave Kilberg my business card and informed him I would check with the asset protection staff to see if any collision could be observed on their security cameras. Kilberg departed. I entered Walmart and spoke with Asset Protection Associate Cody Sanders and we observed security camera footage from the time Kilberg parked his truck to the time he exited the store and returned to the truck.

I did observe a white Jeep Cherokee with an unknown registration pull out of the space adjacent to Kilberg's truck. The angle was poor and the quality of the recording was equally poor. I did not see any indications of Kilberg's truck moving as a result of being struck. As the Jeep drove close to the security camera, I could not see any signs of damage to it. However, with the absence of any dents on the truck and the light rub, any contact between the two vehicles was at an absolute minimum. I cannot determine whether the Jeep did or did not make contact with the truck. I could not make out the registration of the Jeep. I saw a white female driving the Jeep.

I have no suspects or leads in this case.
