

NARRATIVE

Unit 1 was traveling northbound on North Dixie Drive approaching Benchwood Road. Unit 2 was traveling southbound on North Dixie Drive and was stopped and waiting to turn left onto Benchwood Road. Unit 2 turned left and was struck by Unit 1 in the front right of the vehicle. Unit 1 claimed the light had turned red, and unit 2 claimed the light was yellow when she went through. There were no independent witnesses to prove fault. Unit 2 was found to be driving under suspension.





Unit 2 said that he was stopped for traffic while southbound on North Dixie Drive and was waiting to turn left at the light at Benchwood Road. He said the light cycled to yellow and then to red. He said he turned, but unit 2 ran the red light, as she was traveling northbound on North Dixie Drive.

Unit 1 said as she was approaching Benchwood Road, the traffic light cycled to yellow. She said she was too close to stop and proceeded through the yellow signal, but unit 1 turned in front of her, causing the collision, as she had tried to maneuver to miss him.

I spoke with unit 1's passenger while unit 1 was being examined by a medic. The passenger said she did not see what happened. I also spoke with another driver, who had stopped. She also said she could not say what cycle the light was in, as she only heard the collision and noticed the crash afterward.

At this time, there are no independent witnesses to aid my investigation. Although unit 2 failed to yield to unit 1 as he turned, I can't prove the light cycle at the time, and who had the actual right of way. I did not issue any citations based on this fact.

I did cite unit 2 since he was under an FRA suspension according to LEADS. He could not provide proof of insurance, or his driver license, and he claimed he had a court order allowing him to drive. It should be noted that LEADS showed his insurance was cancelled in June.
