



On September 9, 2017, at approximately 0126 hours, I was standing in the parking lot of Wings Bar & Grille while on another call when I witnessed this accident.

I was standing approximately 30 feet away when I first noticed a white Nissan Frontier pick up truck backing out of a parking spot at a quick pace. I watched as this vehicle backed into another parked vehicle directly in front of me. After the impact, the driver, a black male in his mid to late twenties looked back briefly before putting the truck in drive and pulling away heading toward the exit.

I yelled at the driver while shining my flashlight on him as I approached on foot. The driver looked in my direction and then accelerated as he pulled out onto N. Dixie Drive heading north. I was able to read the vehicles New Jersey registration, V30JAG to the dispatcher as the suspect drove away. The suspect was last seen heading east on York Commons Blvd from N. Dixie Dr.

Upon checking this vehicle's registration in L.E.A.D.S., I discovered it was registered to EAN Holdings LLC, a company that supplies Enterprise Rental with vehicles.

Upon contacting the Enterprise Rental Company's, Law Enforcement Division, I was able to obtain the current renters information which included an address of 4162 Mapleleaf Drive, Dayton, Ohio. I contacted MCSO to have a Deputy check this address for the suspect vehicle which was there at the time.

I responded to this address at approximately 0420 hours and made contact with the suspect who was identified as Devinn L. Cross. The renter of this vehicle, Toni Liggins, Devinn's Mother was also present at this time. At first, Devinn admitted to being at Wings but denied striking any vehicles in the lot. After I advised Devinn I was standing in the parking lot and personally witnessed the crash, he confessed to hitting the vehicle and leaving the scene. Devinn advised he did not realize it was a police officer yelling at him to stop. When I asked Devinn if he had a valid drivers license, he stated no. Toni appeared to be legitimately surprised that Devinn did not have a valid drivers license at the time. I would later learn that Devinn just returned to Ohio after living in Atlanta for some time. Toni rented the truck for Devinn to move his property back home but insists she had no idea he was not a valid driver.

I issued Devinn citations for leaving the scene of an accident, failure to maintain control, and operating a vehicle on a suspended drivers license. A copy of the written citation was issued to Devinn before he was released.

I contacted the owner of Unit 1 by phone to inform him of the situation. I also provided him with a business card including this case number for insurance purposes.
