



On March 8, 2018, I responded to Butler Township Police Department and met with Ashley Kirksey who advised she was just involved in a crash. Ashley went onto explain that the second vehicle involved in the crash was a white Chevrolet Trailblazer, which was being driven by an older black female wearing glasses.

I observed front end damage on Ashley's vehicle that had white paint transfer on her bumper. I began to photograph the damage, Ashley advised that this occurred in the intersection of N. Dixie Drive and N. Sunny Ridge Rd. Ashley stated that after she struck into the side of the trailblazer, she went to get out of her car. She said she then observed the white Trailblazer leaving the area heading northbound on N. Dixie Drive.

Ashley stated she was southbound on N. Dixie Drive, when she observed the white Trailblazer pull out in front of her. She stated that she tried blowing her horn to get the driver's attention, but there was no time to stop or get out of the way. Ashley then said she struck the vehicle's driver side door.

I responded to the area attempting to locate where the crash occurred, but I found no tire marks or debris on the roadway. I then patrolled the area of Sunny Ridge in an attempt to locate the suspect vehicle, but I was unable to locate it. I have no further leads on the suspect or suspect vehicle.
