





I was dispatched to the Walmart located at 3465 York Commons Blvd in reference to a hit and run crash in row 6 in the parking lot. When I arrived I found that the owner of the vehicle was not in the vehicle when it was struck and did not witness the crash.

I spoke to Dustin Allison, a bystander who told me he witnessed the crash. Allison said a small grey station wagon-like vehicle backed out of a parking spot on the north side of the row. The vehicle backed until it struck the rear of a black Impala parked on the south side of the row. The station wagon (unit 1) then left west in the lot and then turned south exiting the lot onto York Commons. Allison said the license plate on the unit 1 vehicle was DPR2323. He described the driver as a black female in her 50's. I obtained a written statement from Allison.

I checked the black Impala. I did not see any damage to the back of the vehicle but the owner's husband felt that the trunk was misaligned as a result of the crash. I did not take photos of the Impala due to the lack of visible damage.

The registration provided by Allison returned to a Sheila Revels with an address of 427 Water St, Dayton, Ohio. I could not find a phone listing for Revels. We were getting busy at the time so I requested that Dayton Police respond to that residence to check for the vehicle.

Officer Hayslip was contacted by Walmart asset prevention. They gave him a video of the incident showing what Allison described. Unit 1 hit unit 2 hard enough that the driver had to know she hit another vehicle.

Dayton Police Department contacted dispatch to advise the address given was an apartment building and they did not know which apartment to check. They stated that the suspect vehicle was not in the parking lot when they were there.

On April 20, 2018 I made telephone contact with Sheila Revels. During our phone conversation Ms. Revels admitted to having been the one driving unit #1 at the Walmart on the day and time of the crash. Revels admitted backing into another parked car but stated she got out, checked for damage, and finding none left. I told her we had video that did not show her stopping or getting out to check. She continued to say that she did. Revels said she would come to the PD later tonight to write a statement and view the video. She called dispatch later and said she could not make it tonight but was willing to come in on the 21st. I spoke to Sgt. Stanley who said he would deal with her if she showed up due to the fact that I am off on the 21st.
