





On April 22, 2018 at 1522 hours I was dispatched to a two vehicle property damage crash, on Miller Lane at Benchwood Road, and the at fault vehicle was fleeing the scene. Upon arrival I spoke to Larry Ferguson who advised that a white male subject, driving a Gold Ford four door, bearing Ohio registration HHG8845, struck the rear of his vehicle. Ferguson got out of his car, walked back to the other driver. As he began to talk to him, the other driver stated that he was late picking up his daughter and fled the scene, driving erratically.

There was a passenger in the car with Ferguson who also saw the driver of the Ford that struck them. She described him as middle aged, white male, thin face, 5'8'' , around 140 pounds. She stated that

I made contact with the registered owner of that vehicle, identified as Shannon D. Iddings. Iddings advised that her ex husband was driving the car, identified as Roy Staten III, Iddings stated that Staten had just called her and said that he had been in an accident in her vehicle and it was only minor and not to worry about it if she got any calls. I called Staten and left several messages advising him to call me, and he never returned my calls. I had the Miami County SO go by the address and they no longer lived there.

I made contact with Iddings on April 26, 2018 and she stated that Staten had called her and advised that he was going to call the police department, he never did. After running Staten through our LEADS system, it was discovered that his license is suspended. After many attempts to get Staten to return my calls, with no response, I would consider him uncooperative at this point. I issued a citation for Staten for ACDA, DUS, and also a complaint form for leaving the scene of an accident.
