**NARRATIVE**

Unit #1 was traveling north on Frederick Pike in the right lane and when at 8201 Frederick Pike attempted to make a left turn to travel west into the parking lot of 8201 Frederick Pike and in doing so, failed to yield the right of way to oncoming traffic causing Unit #2 which was traveling south on Frederick Pike in the right lane, to make an abrupt move in the attempt to avoid colliding with Unit #1.

The abrupt move of Unit #2 caused Unit #2 to drive left of center and into the yard of 8130 Frederick Pike and strike a tree that was in the yard of 8130 Frederick Pike, causing Unit #2 to turn around and face northwest bound.

On Friday, May 25, 2018 at 0828 hours, Unit #1 was traveling northbound on Frederick Pike in the right lane and when at 8201 Frederick Pike in Butler Township, stopped in front of this address on Frederick Pike to look for a place to park in the small parking lot. The parking lot is the business of Monnin Fruit Farm and the business was very busy on this date and time of accident.

The driver of Unit #1 Charles Ullery attempted to turn into the parking lot of 8201 Frederick Pike, and when Unit #1 started to turn causing the left front part of his vehicle to cross into the southbound lane of Frederick Pike, Unit #1 saw Unit #2 driving towards him in the right southbound lane of travel at what appeared to be a speed greater than the posted speed limit.

Unit #1 straightened his vehicle just as Unit #2 was beginning to pass. Unit #2 swerved to avoid an accident, over corrected and drove left of center and into the northbound lane of travel. Unit #2 drove into the yard of 8130 Frederick Pike and struck a tree in the front yard of this residence with the left front fender of the vehicle. The motion of the vehicle caused the vehicle to spin around and face Northwest. The occupants of Unit #2 were not injured. Unit #1 was not struck by Unit #2 and no damage occurred to Unit #1.

The witness to the accident stopped to check on Unit #2, and provided a written statement to what was witnessed. The witness information was added to the accident report.

Unit #2 did not have any insurance information, and could only state she had "The General" insurance. Unit #2 did not contact the police department to provide her insurance information and no other contact was able to be established with Unit #2. No insurance information could be collected for Unit #1.

The resident of 8130 Frederick Pike advised that the property was a rental and she provided the property owners information. See below.
