



On Sunday, June 17, 2018 at 0408 hours, I was dispatched to 8970 North Dixie Drive in Butler Township, Montgomery County, Ohio regarding an injury accident with a vehicle into a utility pole.

Upon arrival, Butler Township Medics were on-scene and evaluating the driver of the vehicle. The driver / owner of the vehicle was identified as Brian K Jenkins Jr. Mr. Jenkins handed me his wallet to remove his drivers license. I removed the drivers license from the wallet and did not locate an insurance card for the vehicle. I returned the drivers license to the wallet and returned the wallet to Mr. Jenkins.

Mr. Jenkins was laying on the medic cot. Mr. Jenkins stated he could not recall what caused the accident. Mr. Jenkins stated he was by himself at the time of the accident.

The vehicle involved in the accident was a black 2007 Infiniti G35X with Ohio license plate HFY5293. The vehicle is registered to Mr. Jenkins. The vehicle had excessive front end damage. The vehicle appeared to have drove straight into the utility pole #39330. The windshield of the vehicle was cracked from the impact and airbag being deployed. There were no indication that Mr. Jenkins struck the windshield with his head.

The interior of the vehicle had the airbag deployed on the steering wheel including the left side, front and rear airbags of the vehicle. There were no blood inside the vehicle, or an odor of an alcoholic beverage coming from inside the vehicle.

Officer Ashworth was on-scene to assist with the crash and took photographs of the scene while I conducted the investigation. Dayton Power and Light was notified and responded regarding the utility pole being moved during the accident.

I met with Mr. Jenkins inside the ambulance to obtain additional information. I did not smell and odor of an alcoholic beverage inside the ambulance. Mr. Jenkins was transported to Grandview Hospital by Butler Township Medics for non-life threatening injuries.

An unknown passerby stated they witnessed Mr. Jenkins walking on the side of the building at the address the accident occurred. I checked the side of the building and located an unknown rubber type object, one receipt and various pieces of paper. The receipt had Mr. Jenkins name on the receipt. The misc items were photographed and returned to the vehicle.

While conducting the crash investigation it appears that Mr. Jenkins was in the left inside lane of North Dixie Drive traveling southbound. Mr. Jenkins proceeded to cross the center line of travel and into the northbound lane of travel. Mr. Jenkins crossed all northbound lanes of travel and drove over a curb in the parking lot of 8970 North Dixie Drive and struck utility pole #39330 head-on with the center from of his vehicle. Utility pole #39330 is encased in asphalt and was pushed backwards causing the utility pole to sway back and forth in the ground. Dayton Power and Light was notified and responded to evaluate the utility pole. The utility pole was replaced by Dayton Power and Light.

I completed a vehicle inventory form for Mr. Jenkins vehicle. I was unable to inventory the truck. Mr. Jenkins had the key fob to the vehicle on his person and he was enroute to the hospital. Mr. Jenkins vehicle was towed to Busy Bee Towing on a flat bed.

I completed citation number 43253 and had the citation served to Mr. Jenkins by Vandalia Municipal Court.
