





On Thursday, June 21, 2018, I was dispatched to the intersection of Yorkshire Drive and Fernside Court for a report of a hit and run crash involving a stop sign. Upon arrival, I located the stop sign, and I observed that it had been snapped in half. I also noticed a tire track leading through the grass just before and after the stop sign's location.

While on scene, a witness of the crash approached me and told me that the suspect vehicle was a newer Ford F-150, which was grey in color. I fixed the stop sign the best I could and began to patrol the area of the Fernside neighborhood in search for this vehicle.

I then located a vehicle that matched the description in the driveway of 7052 Society Court. As I began to walk up the drive way, I heard a loud cough from the front porch of this residence. Here, I made contact with owner of the truck, Steven Buchholz.

I advised Steven of the broken down stop sign and told him about a witness seeing a vehicle that matched his truck. Steven immediately stated that he did not hit a stop sign and had been sitting on his front porch for several hours. I then began to look over the truck and discovered several signs of recent damage on the truck, such as deep scratches on the front bumper, and also his passenger side mirror had been smashed. There were also scratch marks leading down the entire side of the truck.

After speaking with Sergeant Stanley for several minutes, Steven finally admitted that he must have hit the stop sign. During this time, I also had a witness, Aaron Kenney, drive by the residence and confirm that this was the vehicle he saw hit the sign.

I then took photos of the damage on the truck. I issued Steven a citation for failure to control and warned him on leaving the scene of a crash.

After clearing this call, I met with Michelle, who lived at 7155 Yorkshire Dr. Michelle stated that she had video footage of the crash. This video was also attached.
