On Saturday, July 14, 2018, at 1355 hours, I was dispatched to the Hooter's, located at 6851 Miller Lane, in Butler Township, Montgomery County, Ohio, for a private property hit skip crash.

Upon my arrival at 1357 hours, I made contact with the registered owner of a tan colored Chevrolet Cruz, bearing Ohio registration HKM7851, and who I identified as Andrew T. Roberts, and received his report. Roberts stated that he parked the Chevrolet in the parking lot at the beginning of his shift. Roberts continued that he was notified by a fellow employee that a vehicle, which was previously parked adjacent to his vehicle, had pulled out of its parking space and had struck Roberts' vehicle. Roberts stated that the color of the truck was tan.

Roberts reentered into Hooter's and returned with James P. Hall, who had witnessed the crash. I identified Hall via his name and date of birth. Hall stated that a 2006 or 2007 Dodge Ram crew cab diesel driven by a white male wearing a straw cowboy hat, white tank, and gray shorts had pulled out the the adjoining parking space and had cut a sharp right. Hall continued that the vehicle then struck the left front corner of Roberts' vehicle and departed in an unknown direction. Hall stated that the color of the truck was green and further stated that the truck was lifted. I obtained Hall's telephone number of (937) 250-3459.

I entered into Hooter's and spoke with the wait staff. They knew the hit/skip operator only as Justin and often referred to him among themselves as "Kenny Chesney." They stated he was a semi-regular customer who comes in on the weekends. None of the staff present knew of Justin's full name and stated that he had paid for his purchases with cash. I gave the bartender my business card and requested they call me the next time Justin returned.

On Monday, July 23, 2018, I returned to Hooter's and spoke to the wait staff. They stated that they had not seen Justin since the incident.

I have no further leads at this time to identify Justin or the Dodge truck he drove.
