

NARRATIVE

Unit #1 was traveling west on Benchwood Road in the left turn lane and when at Miller Lane attempted to make a left turn to travel south on Miller Lane and in so doing, failed to yield the right of way to oncoming traffic and collided with Unit #2 which was traveling west on Benchwood Road in the right lane.

While Unit #1 was attempting to make a left turn (south) onto Miller Lane, Unit #3 was attempting to make a left turn onto Benchwood Road from Miller Lane and collided with the passenger side of Unit #1.



On Thursday, August 23, 2018 at 0811 hours, I was dispatched the Benchwood Road at Miller Lane in Butler Township, Montgomery County, Ohio regarding a non-injury accident. Dispatch advised two of the drivers relocated to the parking lot of Ruby Tuesdays 6425 Miller Lane. The third driver left the scene of the accident.

Upon arrival, the drivers stated they were not injured. The driver of Unit #1 Mark Ohara stated he was making a left turn onto Miller Lane from Benchwood Road when he was distracted by another vehicle. Mr. Ohara stated while attempting to make a left turn, he pulled in front of Unit #2 and struck the left front of Unit #2 with the right front of his vehicle.

Mr. Ohara stated when the accident occurred he was struck on the right side of his vehicle by Unit #3, described as a white 2004 Buick Lesabre with Ohio license plate GUV2968. Mr. Ohara stated the driver of this vehicle was not injured.

Mr. Ohara stated the three drivers decided to relocate to the parking out.

The driver of Unit #2 Sedaric Dinkens confirmed the accident as described by Mr. Ohara.

Mr. Ohara stated he spoke to the driver of Unit #3. Mr. Ohara stated they decided to exchange information and he collected a name and phone number from the driver. The driver provided a name of Steven Richardson with a telephone number of 937-607-7579. The driver was described as a black male, approximately 50 years of age. Mr. Ohara stated the vehicle was leaking motor fluids. Mr. Ohara stated while speaking with Mr. Dinkens, the driver of Unit #3 left the scene without collecting additional information from him.

Mr. Ohara was able to take photographs of Unit #3 prior to the vehicle leaving the scene. The license plate on the vehicle returns to a Phyllis A. Pursiful 71 year old female.

I photographed Unit #1 and Unit #2, including obtaining written statements regarding the accident.

Unit #2 is a rental car from Enterprise Rental Car 4600 International Gateway, Columbus, Ohio 43219 with phone number 614-239-3200. Mr. Dinkens stated he was covered under the insurance he purchased for the vehicle through Enterprise Rental Car. Agreement number 342514198.

Mr. Dinkens contacted Enterprise Rental Car and advised them of the accident. The vehicle was towed by Enterprise Rental Car.

I called the phone number provided by Unit #3. The phone number did not work. Additionally, I searched for a name provided, Steven Richardson. There were multiple subjects with the same name in LEADS. I was unable to determine which Steven Richardson was the correct person or if that was the real name of the subject.

I completed an exchange of information for Unit #1 and Unit #2. Additionally, I completed citation number 003515 for Mr. Ohara. I explained and issued the exchange of information Mr. Ohara and Mr. Dinkens. I also explained and issued citation number 003515 to Mr. Ohara for failure to yield while turn left with a court date of August 30, 2018 at 0830 hours.

Mr. Ohara was able to drive his vehicle from the crash scene. I was unable to locate a telephone number for the owner of Unit #3. I will forward this report to investigation for additional investigation.
