On Saturday, September 8, 2018, at 0116 hours, I was dispatched to Frederick Pike at West National Road on a reported crash. One unit had fled the scene and dispatch had no other information. The caller had pulled into the Polk Grove Cemetery, located at 9190 Frederick Pike.

I arrived at 0123 hours and met with the caller, Jeanna Long, and her passenger, Paula Morgan. Ms. Long explained that she was driving northwest on Frederick Pike and following her GPS to get to her destination. She was driving about 30 miles per hour because it was raining, and she was not familiar with the area since she was from out of state.

As she approached Polk Grove Cemetery, she saw a red 4 door car parked in the middle of the roadway and blocking both lanes. She said the car was parked facing the east toward the cemetery and well past the entrance. She applied her brakes but did not have enough reaction time due to it being dark and the rain. She slid and collided with the passenger's side of the vehicle which caused damage to both vehicles. She said the red car was damaged enough that she did not think the back door would be able to open.

She said the car was empty, but she saw another truck (unknown description) in the cemetery, and a black male talking on a cellular phone who was walking from the direction of the truck within the cemetery. She described the male as being very dark and estimated his age to be around 30. She also added that due to the darkness, she was not sure of his description or the type of car.

She began calling her friend, who was the owner of the truck, and the male asked who she was calling. He then said he did not have a license or insurance, and he told her not to call the police. He got into the vehicle and drove toward West National Road. He turned eastbound onto West National Road and fled the scene without providing any information. The other truck had also fled the scene. She pulled into the lot and called 911.

She said she did obtain the license plate and provided HJW4779, which was an Ohio plate. I learned this returned to a red 2006 Dodge 4 door and was registered owner Jamyalah A. Rutledge. I requested dispatch to put a teletype out for the vehicle and to have the agency of jurisdiction check the address.

I obtained written statements and took photographs. I provided my business card with the report number. Ms. Long had already made a claim to her insurance company. I cleared the scene. I later learned that Miamisburg PD had made contact with the owner at her residence. She told the officer that she had loaned her car to Malik Wilkenson. She said that Malik lived in the Drexel area, and she used FaceBook to contact him since he did not have a phone. She said she had not heard from him in hours.

At approximately 0310 hours, I heard Miamisburg PD get dispatched back to Ms. Rutledge's address because Malik and the car had arrived there. Officer Bell of Miamisburg PD confirmed the car and driver were at the scene. I began driving to their location but had to clear due to rolling up on an OVI crash on the interstate.

Officer Bell said that Malik did not wish to give a statement, and he claimed to have a valid driver with him. He said he had been there meeting a family member, but he offered no explanation for parking the vehicle on Frederick Pike. He did have a valid temporary permit. I also learned that Ms. Rutledge did not have insurance on her vehicle, and Malik also did not have insurance.

Officer Bell sent me photographs of unit 1. He was unable to complete a statement about Malik's version of events due to a busy shift. He advised he will submit it to me at his earliest convenience to be added to the report.

At this time, I had not issued any citations due to the fact I was unable to respond to the Miamisburg
