



On Saturday, September 08, 2018, at 2139 hours, I was dispatched to the Shell gas station, 584 W. National Road in Vandalia, for a hit and run crash. I was advised that Vandalia PD was already out with Unit #2 and that the crash had occurred at Peters Pike at Hertlein Lane in Butler Township.

I drove through the area of the reported crash prior to arriving at the Shell gas station, and I attempted to look for any remaining evidence before it was destroyed or wash away from the heavy rain at that time. I was not able to locate anything.

I arrived on scene and made contact with Officer Steitzer #187/VPD, who advised that he had the license plate of Unit #1, which he gave to me as F533412. The plate returned to a 2001 Toyota, and the owner was a Dorothy L. Brookins. Officer Steitzer had already called Ms. Brookins, and she had stated that it would have been Tequila Dansby, who was driving the car.

She stated that Ms. Dansby lived in Vandalia somewhere, but she was not sure where. I looked and found that her last address was 148 Santa Clara Ave. Apt #4 in Dayton. I contacted DPD to check and advise, and they later stated that she did not live there and they did not have a follow up address.

I spoke with Unit #2, who I identified as Steven Mattis. Mr. Mattis' vehicle was a 2015 Nissan Sentra with Ohio registration GNN8752. Mr. Mattis advised that as he was traveling north on Peters Pike and was slowing in an attempt to turn right onto Hertlein Lane, he was then struck in the back by a silver vehicle.

Mr. Mattis stated that the vehicle fled the scene, and he followed them to the northern intersection of Peters Pike and US 40 (West National Road.) This was where the vehicle tried to turn back around south, and Mr. Mattis stated he blocked the vehicle, and the vehicle then ended up turning east onto West National Road.

Mr. Mattis advised that, at this point, he was able to get close enough to view the license plate, which he provided as Ohio temporary tag F533412. He also advised that he was able to see that the driver was an "African American" female. He said that the female then went left of center to get around another car and then turned onto Dellsing Drive.

Officer Steitzer stated that another VPD unit had searched all the surrounding areas, but he was not able to locate the vehicle.

I contacted Ms. Brookins, but I had to leave a message. I advised her that I would like to talk to Tequila in reference to this crash. I took photographs of the damage to Unit #2, and Mr. Mattis completed a written statement, which was added to the case.

I returned to work on September 11, 2018, and I checked my email. On Sunday, September 09, 2018, at 2251 hours, I received an email from the Huber Heights dispatch center in reference that Ms. Dansby attempted to talk to me. I also received information from Officer Smith, that he and Officer Nagel/VPD had located Ms. Dansby at the address of 870 Continental CT APT #8 in Vandalia around 0000 hours on 9/12/18.

Ms. Dansby was arrested for a previous driving under suspension warrant out of Dayton, and her vehicle was located. The vehicle was photographed for damage, which was consistent with the ACDA crash. The vehicle had new plates in the front and rear window, but it still came back to Ms. Brookins. Ms. Dansby had declined to talk in reference to this case.

Ms. Dansby stated to Officer Smith that she had insurance for the vehicle, which was Allstate, and that the information was in the glove box of the car, but he was not able to locate it.

On September 12, 2018, at 2210 hours, I served this citation to Ms. Dansby. I advised her what the

ticket was in reference to, and she stated she did not stop because she was scared of the other driver and how he was driving to catch up to her. I advised her that she needed to contact the police department if this happened, and we could meet her at a safe location.

Ms. Dansby was given a court date of September 19, 2018, at 0830 hours, at the Vandalia Municipal Court. She was advised her appearance was mandatory, and she needed to bring proof of insurance. She advised that she understood and would comply.
