

On Sunday, September 16, 2018, at 1710 hours, I was dispatched to a report of a hit and run crash at 3021 Benchwood Road. The caller advised that the female suspect, who had been driving Unit #1, was an older white female he believed to be intoxicated. Unit #2, which had been parked unoccupied in the parking lot of 3021 Benchwood, observed the damage to his vehicle and began to follow Unit #1.

Unit #2 followed this vehicle, as they made their way to Circle Court in Fairborn, Ohio. Fairborn Police received a call of the reckless driver of Unit #1, and they located and stopped the vehicle. Officer Karolyi made contact with the driver of Unit #1, who was identified as Mary Griffith and arrested her for OVI.

I arrived on scene and gathered the information for my crash report. Unit #2 advised he was inside the address of 3021 Benchwood Road, and he witnessed Unit #1 back through the parking lot and strike his vehicle causing damage to his rear bumper and tail lamp.

Ms. Griffith was issued a citation for failure to control and leaving the scene of an accident. She citation was issued as a summons to appear at the Vandalia Municipal Court on Tuesday, September 25, 2018, at 0830 hours.



I ran outside to see a white older woman pulling off while my car was still shaking from the hits.
