





On Saturday, September 29, 2018 at 1440 hours, I was dispatched to Lightner Road at North Dixie Drive in Butler Township, Montgomery County, Ohio regarding a crash between a semi truck and a Jeep Wrangler.

Upon arrival, I made contact with both drivers of Unit #1 and Unit #2 and no injuries were reported. While checking for damage to both units, Unit #1 does not have any damage and Unit #2 have very minor damage to the front bumper.

Unit #1 stated he was turning north onto North Dixie Drive from Lightner Road and while making the turn he briefly stopped and the truck had rolled backwards, however denied backing up. During the incident, Unit #1 backed into the front of Unit #2 that was stopped at the stop sign.
