On December 04, 2019, at 1844 hours, I was dispatched to a property damage crash at Martindale Road and Frederick Pike.

While en route dispatch advised that the caller reported a silver mini van and a black car had been involved in a crash. The caller later advised that the mini van had driven off with a license plate of FBN4103.

Dispatch then further advised that the driver of the car had told a witness not to call police "because he did not have insurance", but the car was disabled and left at the scene with license plate HDE3911. The operator walked away from the vehicle and left the scene.

As I arrived on scene I noticed a Black Hyundai Elantra on the side of the roadway just north of the intersection of Frederick Pike and Martindale Road. The vehicle had heavy front end damage and passenger side damage. I noted that the airbags were deployed on the drivers side and a key fob was in the cup holder in the center console. I did not locate any blood in the vehicle or around it.

A witness, later identified as Benjamin Barker stated that a younger white male with a tan Carhart type jacket, he had short almost shaved dark hair. Mr. Barker advised that the male had exited the drivers of side of the Black Hyundai and was asking if anyone had called the police, which he seemed agitated about the subject according to Mr. Barker. Mr. Barker advised that the male then took off down Martindale around 1855 hours. Mr. Barker lives at the intersection and stated that he did not see a mini van involved with the crash.

I contact Union PD to check the residence of the registered owner a Nicholas Benvenuto. Union PD advised that the lights were on in the house, dog barking, but no answer.

I contacted Busy Bee Towing and had the vehicle towed to the lot and placed on hold.

I contacted witness Heather Campbell who stated that she was not far behind the black Elantra going northbound on Frederick Pike. She advised that she had seen the cars tail lights bouncing up and down on the right side of the roadway and ultimately crash. She advised that a silver mini van was at the stop sign on Martindale facing east. She advised that the mini van did have front end damage but could not tell if it was involved in a crash with the black Elantra. She stated that she had got out of the vehicle and check on the driver of the Elantra who was upset that she had called the police, and left. She stated that she checked on the mini van operator who stated that they were fine, and they left the scene. She advised that she could not tell if they were involved in this crash.

at 1010 hours on December 5th, I was contacted by Officer Ashworth who stated that Mr. Benvenuto had contacted dispatch asking about his vehicle. A call was created with dispatch number 19-085518, which I linked to this case. Mr. Benvenuto stated that he had crashed his car into a ditch overnight and wanted to know where his car was. Mr. Benvenuto further advised that he was told by his girlfriend who had driven by that scene that his car was no longer there. Mr. Benvenuto stated that the airbags had deployed and he was disoriented. He advised that he remembers the crash happening at 1830-1900 hrs the night prior.

I asked Officer Ashworth to make contact with Mr. Benvenuto and issue him a traffic ticket for failure to maintain control. Officer Ashworth completed a ticket and provided him with his copy. Mr. Benvenuto declined to do a written statement but had mentioned that a deer was in the roadway. There was no evidence on the scene of a deer. Mr. Benvenuto did not advise another vehicle was involved or offer any other information about the incident.

Officer Ashworth collected insurance information and it was added to the call.

I advised Officer Ashworth that Busy Bee could release the vehicle which he contacted Busy Bee and

Mr. Vincent advised that he had seen the vehicle leave the roadway and crash. He advised that he did not see a deer and that he had left for church after asking the operator if he was ok.
