

NARRATIVE

Unit #1 was traveling west bound on York Commons Blvd in the left turn lane and when at North Dixie Drive attempted to make a left turn to proceed south bound on North Dixie Drive and collided with Unit #2 that was traveling north bound on North Dixie Drive in the inside lane of travel.

Both drivers claimed to have had the green light alledging the other had ran the red light causing the accident. There were no independent witnesses or cameras to elimatte either driver as being at fault.

No citation was issued.


