



On April 19, 2019 at 1941 hours I was dispatched to the area of Benchwood road and Miller lane on report of a hit skip crash. Upon arrival I spoke to T.J. Owens who advised that he was driving a Kenworth Tow Truck, bearing Ohio registration PHB2625, traveling west on Benchwood Road, turning north onto Miller Lane, in the right hand turn lane of travel, and a Kia mini van bearing Ohio registration HQE9940 came around im on the left then turned into his truck and struck the driver side front.

That vehicle was driven by a black female subject, who fled the scene to her home address, 5095 Northcutt Dayton, OH 45414. I did locate the van at the residence with heavy front end damage, and the plates had been removed from the vehicle. The owner of the vehicle, identified as Nefretiri R. Polk, fled her residence on foot upon my arrival. Polk then called dispatch and advised that someone stole her vehicle, and just returned it with damage to it, however she refused to come back to the scene and speak with me. Days later Polk called our dispatch center and advised that she wanted to speak with me. I did reach out to her by phone and she advised that she was driving the car when she struck the tow truck. Polk stated that she fled the scene because her plates were expired and she did not have any insurance. I advised Polk that I would issue her a summons and some citations, instead of taking her to jail, if she would come to the police department and get them. Several days past and I did not see Polk, Once again I reached out to her by phone and advised her that if she would just stay where she was I would come to her and issue her the citations and summons, with a court date.

I did meet with her at her address and issue her the paperwork with a court date.
