On April 1st, 2019, I responded to the intersection of Peters Pike and Little York Rd for a traffic crash with possible injuries. I arrived on scene and met with the driver of Unit #2, Brittany Siders. Brittany was up and walking around. Initially she advised she was ok and did not need medical treatment. She later requested a medic due to soreness throughout her body. Brittany was taken to the hospital by Butler Twp medics for further evaluation.

I then spoke with a witness to the crash, Meghan Miller. Meghan advised she was idle in the left hand turn lane, south on Peters Pike, preparing to turn east onto Little York. She stated her light turned green and unit #2 was approaching her heading north on Peters Pike. Meghan stated she was yielding to unit #2 before making her left turn onto Little York Rd. She advised Unit #1 was traveling west on Little York Rd and proceeded through the red light at Peters Pike, striking/struck by Unit #2.

The driver of unit #1, Philip Eikenberry, advised his light was yellow and felt he was not at fault. He had no injuries, nor did his wife, Norma Eikenberry, whom was in the front passenger seat. Philip was issued a citation for failure to obey a traffic control device. All vehicles functional and drove off scene; photos taken.
