

On Thursday, May 9, 2019, I responded to the area of 7255 Dog Leg Road for a report of a single car accident that was unoccupied. Upon arrival, I located the vehicle that had spun out from what it appears to be speed related.

Bailey and Sons towing arrived on scene and stated a unknown female contacted the company requesting a tow. The tow truck driver attempted to contact the female back, and when he told her that the police were on scene she hung up the phone. The driver of Baileys advised the driver stated she worked at P&G in Union.

After further investigation the rear plate on the vehicle was found to belong to another. The plate found on the vehicle was bearing Ohio registration HQE9665, belonging to a teal 1998 Dodge 4 door. I removed this plate and entered it into evidence for safe keeping. Busy Bee towing arrived on scene, and due to the driver of the vehicle, and the fact that it was partially blocking the road way, the vehicle was towed to Busy Bee where proof of owner ship will need to be validated before retrieving the vehicle.

I responded to P&G in Union to follow up and see if the registered owner of the vehicle worked there. P&G security advised that she did not work there but also stated that a young black female had came to work for her second day of security and told the manager that she was in a car accident and needed to leave work. No one on scene knew who this female was, and did not know her name yet since she is new.

Unit #1 was traveling north bound on Dog Leg Road in the north bound lane, and when at 7255 Dog Leg Road, lost control of the vehicle and spun out of control putting the car into a ditch causing minor damage to the front bumper.
