On Saturday, May 18, 2019 at 1005 hours, I was dispatched to Walmart, 3465 York Commons Boulevard, Butler Township, Montgomery County, Ohio in reference to a hit and run crash.

Upon my arrival, I was met by the owner of Unit 2, Louis Almasy, he advised that while he was in Walmart shopping, several witnesses saw a silver Nissan, bearing Ohio registration GVJ7036, strike his vehicle, then take off out of the lot without stopping.

I provided Mr. Almasy my business card and the report number and advised him I would contact him if I was able to locate Unit 1.

I searched the registration through our system and found that the same vehicle was involved in another hit and in run in Huber Heights in 2017. At that time, the driver of the vehicle was Heather Short, the daughter of the registered owner, Betty Perkins.

I located a phone number for Betty and left her a voice mail advising that I believed her daughter had been involved in a hit and run. Betty returned my call stating that she believed so as well, as she had found fresh damage to her vehicle and Heather is the only driver of that vehicle.

She provided her insurance information, and I requested that Heather contact me.

Heather contacted me, and I asked her about the accident. She stated that she didn't believe she had caused any damage to the other vehicle, but admitted that she did not stop to look.

I advised her I was going to issue her a citation for leaving the scene of an accident, and I needed her to come to the police department.

On May 21, 2019, Heather arrived at the police department where she was served with citation #003888, and advised her of her court date.
