On June 26, 2019, at 2225 hours, I was dispatched to a property damage crash at 7030 Miller Lane.

Officer Dexter and I arrived on scene and made contact with the parties on the access road to Sam's Club near the Asian Buffet. The vehicle to the rear, a 2010 Maroon Buick Lacross with Ohio registration HRG7314 had extensive damage to the front right side of the vehicle. The other unit a 2011 Black GMC Pickup with Ohio registration GPB1853 had an attached red trailer with no plate attached. The trailer had damage to the rear left side and under carriage of the trailer.

I spoke with all the operators and asked if everyone was ok. The operator and owner of the pickup was identified as Aaron Link who stated they pulled out of the O'Charley's parking lot and headed south bound after advising he had checked for clearance. Mr. Link stated that he had seen the other unit going south but stated he had acceptable clearance to continue his motion. Mr. Link and Christopher Gouch, who was the passenger of the pickup and owner of the trailer, both confirmed this story, and stated that they were struck in the rear of the trailer after the trailer and truck had both been straightened in the southern lane of travel on Miller Lane.

Mr. Link stated that when all parties exited the vehicles to check each other, the other unit driver, identified as Michael Collins, who was driving the Buick stated that he is sorry it was his fault and that he was looking at his phone. I did not hear the reason to how he knew Mr. Collins was on his phone at that time of the crash, so I asked him how he knew Mr. Collins was on his phone, and he repeated that Mr. Collins had told him. Mr. Collins was part of this conversation and did not dispute this at all during the conversation. I asked for the parties to get their info and Officer Dexter started collected photographs of the damage.

Mr. Collins had his two year old son with him during the incident in the rear passenger seat in a forward facing child seat. The child did not appear to be injured. The mother later arrived on scene and took their son to Dayton Children's Hospital to be evaluated as a precaution due to his age and damage to the car.

I spoke with Mr. Collins while Mr. Link, and Mr. Gough were completing statements, and Mr. Collins advised that he was traveling south on Miller Lane, and he was messing with his radio, when he did not notice that a vehicle with a trailer attached had pulled out in front of him, and that the trailer was still in a curve and had not straightened yet. Mr. Collins stated that his reaction was to avoid the impending impact and he slammed on his brakes and tried to swerve to the left around the trailer and ultimately struck the rear left corner and associated under carriage of the trailer.

I reviewed the damage and it did appear that the car had slid under the trailers left rear side with the front passenger side of the vehicle. This led me to believe that the trailer had been straightened at the time of the crash.

After reviewing both statements, I advised both parties that I would need to review the scene further due to the conflicting stories, no available witnesses. Both parties left the scene.

I further reviewed the reported crash scene and did not note any debris field was left behind, and I did not notice any shadowing or braking marks of the tires due to heavy braking to support the events as told by Mr. Collins.

No cameras were found to be of evidential value.

Mr. Collins is to be labeled as Unit #1 and a ticket will be issued for assured clear distance ahead.

I have contacted Mr. Collins and advised him of the ticket and that I needed to issue it to him. He stated he would arrive on Monday to retrieve it. Mr. Collins has not shown. The ticket will be sent to the court to serve.
