

Unit #1 was traveling west on Meeker Rd. in the westbound lane, and when at Dog Leg Rd., was unable to stop for the posted stop sign, and entered the intersection, and was struck by Unit #2, which was traveling south on Dog Leg Rd., which does not require traffic to stop. Both vehicles then left the roadway at the southwest corner of the intersection and struck several small trees/shrubs.


