



On 09/17/2020 at 12:54 hours, I was dispatched to Little York Rd. & Peters Pk., on a property damage crash.

As I was responding dispatch advised that 2 black male suspects fled on foot from the crash scene. Dispatch provided a description of one black male wearing blue shirt with gray shorts, and a second black male wearing a white shirt with camo shorts.

On my arrival I located a red Pontiac Vibe, K769488, in the roadway, on Peters Pk., just north of the intersection of Little York Rd. The second car was just to the west of Peters Pk., on Little York Rd. I made contact with that driver, Ann Shafner, and she advised that the red Pontiac was traveling north on Peters Pk. and when at Little York Rd., it ran the red light, causing the second car to strike the Pontiac. Ms. Shafner said that both males came to her car and were "acting shady". She said that they stood in front of the her car and were talking and saying that she was the at fault driver and when she told them they ran the red light, they both ran on foot east on Little York Rd.

After taking photographs, getting a statement, and calling for a tow, I went back to the Pontiac and upon looking in the driver area I located the ID for Dylan Anderson, in the cubby hole next to the steering wheel. Ms. Shafner looked at the ID and stated that Mr. Anderson was the driver and he was the one wearing the blue shirt.

I was able to obtain video from a house that shows Mr. Anderson and the other subject running past. This video had been attached to this report.

The Pontiac was towed by Busy Bee towing, with a hold, due to the driver fleeing the crash.
