IF THIS PERMIT IS GRANTED, I (WE) AGREE TO PLACE A BOND WITH BUTLER TOWNSHIP THAT THE FOLLOWING CONDITIONS WILL BE MET:

1. TO REPLACE STREET SURFACE WITHIN TWENTY FOUR HOURS AFTER INSTALLATION
2. THAT TRAFFIC WILL BE MAINTAINED AT ALL TIMES, UNLESS PERMISSION IS GRANTED BY BUTLER TOWNSHIP TO CLOSE THE STREET
3. THAT THE DISTURBANCE TO THE STREET SURFACE AND SHOULDERS WILL BE KEPT AT A MINIMUM AND THAT TRENCHES WILL BE BACKFILLED WITH GRAVEL AND COMPACTED, SO THAT, SETTLEMENT OF THE MATERIAL WILL BE MINIMIZED; IF SETTLEMENT DOES OCCUR, ADDITIONAL SUITABLE MATERIAL WILL BE PUT INTO PLACE AND COMPACTED
4. THAT THE STREET SURFACE AND ADJACENT RIGHT-OF-WAY AT THE TRENCH WILL BE REPLACED WITH MATERIAL OF THE TYPE THAT WAS REMOVED AND THAT THE NEW SURFACE WILL CONFORM WITH THE GRADE OF THE UNDISTURBED SURFACE
5. THAT LIGHTS, SIGNS, BARRICADES AND, IF NECESSARY, FLAGMEN AND WATCHMEN WILL BE PLACED ON THE JOB FOR THE PROTECTION OF TRAFFIC AT ALL TIMES, DAY AND NIGHT, DURING THE TIME THIS WORK IS BEING DONE AND THAT INSTRUCTIONS GIVEN BY THE "MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES" WILL BE MET
6. THAT I (WE) ASSUME THE RESPONSIBILITY FOR AND WILL SAVE THE TOWNSHIP HARMLESS FROM ANY AND ALL CLAIMS FOR PERSONAL INJURIES AND PROPERTY DAMAGES ARISING FROM THIS WORK, TO THE EXTENT OF \$500,000/\$500,000 FOR PERSONAL INJURIES AND \$50,000 FOR PROPERTY DAMAGES
