#### **RESOLUTION TO REVISE RESOLUTION 03-060 THE FEE SCHEDULE FOR ZONING PERMITS**

**WHEREAS**, on June 23, 2003 the Trustees approved Resolution 03-060 changing the fee schedule for the Zoning Department, and

**WHEREAS**, the Trustees desire to revise the fee payment schedule for the Zoning Department effective January 1, 2011 as follows:


- Residential \$ .10 sf finished/unfinished/attached garages/additions
- Residential \$100 minimum
- Commercial \$ .15 sf finished/unfinished/additions
- Commercial \$500 minimum/\$100 minimum for accessory structures
- Accessory Structures/Residential \$35.00
- Home Occupations \$35.00
- Certificate of Zoning Compliance \$35.00
- Certificate of Occupancy \$35.00
- Use Permit \$35.00
- Permanent Signage/Sign Face Change \$50.00 + \$1.00 square foot
- Pools/Decks/Detached Structures \$35.00
- Zoning Confirmation Letter \$35.00
- Zoning Resolution \$20.00
- Zoning Map \$5.00
- Variance/Administrative Appeal \$250.00
- Conditional Use Applications \$250.00
- Rezoning/PUD applications \$400.00
- Final Development Plans \$250.00
- Major Modifications to Plans \$250.00
- Minor Modifications to Plans \$100.00
- Text Changes \$250.00
- Development Plan/Site Plan Reviews \$250.00 + cost of engineering
- Copies \$.20



**WHEREAS**, the Trustees desire to increase the fees for those activities to cover the labor and administrative expenses for such enforcement, and


**WHEREAS**, the Trustees also desire to establish a fee for miscellaneous services such as snow removal and dirt/earth moving and removal, and


**WHEREAS**, the Trustees desire to revise the fee schedule for Code Enforcement and establish a fee schedule for miscellaneous other services effective January 1, 2011 as follows:


- Grass Cutting \$250.00/hour plus \$50.00 administration fee
- Junk Removal/Clean-up \$250.00/hour plus \$50.00 administration fee
- Trash Removal/Clean-up \$250.00/hour plus \$50.00 administration fee
- Earth Moving/Removal \$250.00/hour plus \$50.00 administration fee
- Towing Junk Vehicles \$50.00 plus the cost of towing per vehicle
- Miscellaneous Repairs \$250.00/hour plus \$50.00 administration fee
- Snow/Debris Removal from ROW \$250.00/hour plus \$50.00 administration fee

**NOW, THEREFORE BE IT RESOLVED**, that the Board of Trustees of Butler Township hereby revises the fee schedule for Code Enforcement and miscellaneous other services as stated herein.


