**Administrator's Report**  
**August 26, 2019**

- 1. Resolution No. 18-29: A Resolution Authorizing the Township Administrator to Certify to the Office of Montgomery County Auditor, for Collection with Property Taxes for the Uncollected Nuisance Abatement and Exterior Property Maintenance Code Enforcement Costs**

Weed abatement and nuisance abatement charges total \$1,521.18 for 2019, including county fee of 5%. Additional assessment charges could be forthcoming, once the cutting season is over. In 2018 we cleaned up 6 properties at a total assessment cost of \$8,157.19.
- 2. Resolution No. 18-30: A Resolution Approving the 2019 Street Lighting Assessments and Authorizing the Administrator to Certify to the Office of the Montgomery County Auditor for Collection with Property Taxes**

Lighting assessment charges for all lighting districts in the Township will be sent to the County Auditor by August 31, 2019. The Total assessment amount is **\$109,483.62**, which includes the county administration fee of 5%. The total assessment was \$107,974.48 in 2018.
- 3. Resolution No. 18-31: A Resolution Authorizing the Township Administrator to Certify to the Office of Montgomery County Auditor, for Collection with Property Taxes, the Costs to Property Owners for Unpaid Solid Waste Collection and Disposal Services**

The total assessment charges will be a maximum of \$46,861.04 for unpaid refuse bills in 2019. These will be sent to the County Auditor by August 31, 2019 for assessment. This includes 157 total accounts. 130 accounts were assessed in 2018, 136 accounts in 2017 and 197 accounts in 2016.
